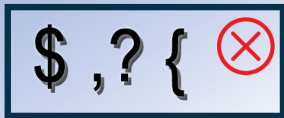
Guidelines

Before printing select "actual size"



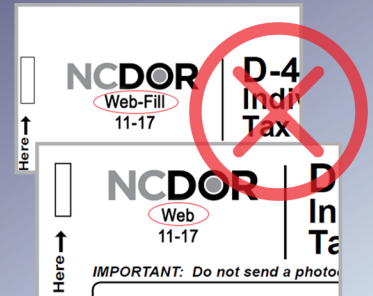
Do not select "print on both sides of paper"

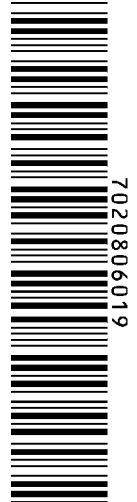
