Do not use brackets for negative numbers

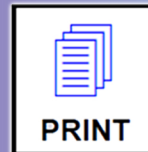
Use a minus sign to show the amount is negative

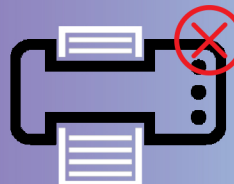
Use the print icon on the form to ensure you have completed all required fields



Before printing, select "actual size"

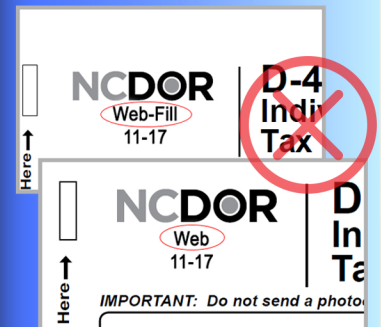


Do not select "print both sides of the paper"

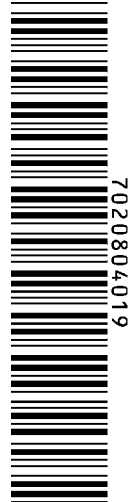
Part C. N.C. Standard Deduction or N.C. Itemized Deductions

N.C. Standard Deduction

Enter the N.C. standard deduction from the chart below:

N.C. Standard Deduction	
<i>(The N.C. standard deduction is equal to the amount listed below based on your filing status, unless you are not eligible for a standard deduction on the federal income tax return. The N.C. standard deduction amount is zero for a person who is not eligible for the federal standard deduction. For more information on eligibility, see the instructions.)</i>	
If your filing status is:	Your N.C. standard deduction is:
• Single	\$ 8,750
• Head of household	\$ 14,000
• Married filing jointly	\$ 17,500
• Qualifying widow(er)/Surviving Spouse	\$ 17,500
• Married filing separately:	
If your spouse <u>does not</u> claim itemized deductions	\$ 8,750
If your spouse claims itemized deductions	\$ 0



If you claim the N.C. standard deduction, **STOP HERE**. Do not complete Lines 15 through 23. Enter the N.C. standard deduction amount on Form D-400, Line 11. If you itemized deductions on your federal return, you may claim N.C. itemized deductions. If you choose to itemize, complete Lines 15 through 23 to determine the amount of N.C. itemized deductions.

Important: If you claim the N.C. standard deduction and you did not complete Part A or Part B, do not attach this form to Form D-400.

N.C. Itemized Deductions

- 15. Qualifying home mortgage interest ▶ 15.
