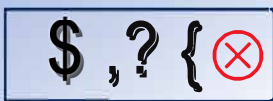
## Guidelines

Do not use dollar signs, commas, or other punctuation marks.



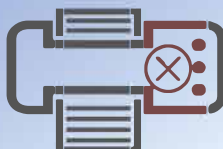
## Printing

Do not select "print on both sides of paper."



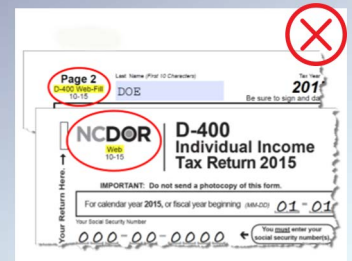
## Before Sending
