

# 2006 Partnership Tax Credit Summary

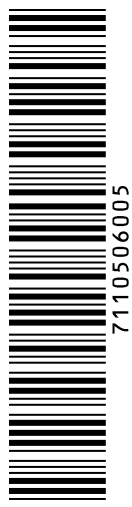
