COMMENTS:

1. *Scrap tire disposal taxes are levied pursuant to Article 5B of Chapter 105 of the General Statutes , and G.S. 105-187.19 provides for a per capita distribution of the proceeds on a quarterly basis.*
2. *This report reflects collections for the months of July 2013 through September 2013.*
3. *Pursuant to S.L. 2013-360, Section 14.16.(a), effective July 1, 2013, the Secretary shall credit thirty percent (30%) of the net tax proceeds to the General Fund.*
4. *Payments of the scrap tire disposal tax proceeds were withheld from those local governments that, per notification from the Secretary of the Department of Environment and Natural Resources, failed to comply with the requirements of G.S. 130A-309.09A(b), 130A-309.09A(d), and G.S. 130A-309.09(B)a, as amended by S.L. 2013-360 and S.L. 2013-409. The withheld scrap tire proceeds were transferred to the General Fund.*
