3. *Payments of the scrap tire disposal tax proceeds were withheld from those local governments that, per notification from the Secretary of the NC DENR, failed to comply with the requirements of G.S. 130A-309.09A(b), 130A-309.09A(d), and G.S. 130A-309.09(B)a, as amended by S.L. 2013-360 and S.L. 2013-409. The withheld scrap tire proceeds will remain in the General Fund.*
