Before printing, select "actual size"

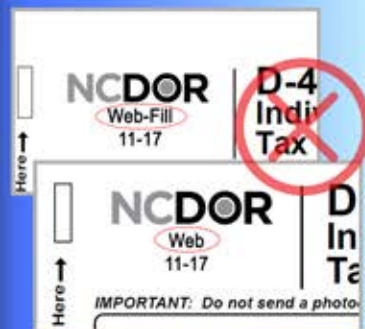


Do not print on both sides of the paper
