

Form NC-5Q File Layout Specifications

Purpose of Document

The purpose of this document is to provide the file format instructions and guidance for the electronic filing of Form NC-5Q.

What's New

• No changes for tax year 2025.

File Format Requirements

- **File Format** The eNC5Q application will only accept fixed-field text (.txt) files; no other file format will be accepted. Some examples of unacceptable formats include comma-separated values (.csv), portable document format (.pdf), Microsoft Word (.doc), and Microsoft Excel (.xls).
- **Testing File Formats** Prior to submitting your file, the eNC5Q application will allow you to test your file layout and confirm if it's formatted correctly. This will ensure your file will be uploaded successfully without generating an error. Step by step instructions to test file formats can be found on our website at www.ncdor.gov/enc5q-step-step-guides.
- Naming Convention for Uploaded Files In the root directory, the file name should be "NC5QRETURN.txt." For each NC-5Q file that will be uploaded, the file name must be unique. If the NC-5Q file requires multiple uploads within the same submission, name your files NC5QRETURN_01.txt, NC5QRETURN_02.txt, etc. This naming convention is a suggested format, however, if your system requires a different format which includes the date and time of the file, please ensure that the each file name includes the form type in the file name (i.e., NC5Q100120181259.txt).

<u>NOTE</u>: File names must not include special characters with the following exceptions: dash (-) and underscore (_). File names that contain restricted special characters will produce errors.

Reminders

- State Withholding Account Number MUST be numeric; APPLIEDFOR is not a valid entry. Please reference <u>eNC3 FAQs</u> for information on how to obtain a withholding account number (if applicable).
- The eNC5Q application will allow the electronic filing of form NC-5Q beginning with the 1st quarter March 2019. All prior year NC-5Q's must be submitted via paper.
- With Tax Year 2022, amount fields allow dollar and cents.

- The application only supports the filing of an original NC-5Q return. Amended return submissions (NC-5X) should be mailed to the Department. You can find these forms, <u>here</u>.
- This application does not support the filing of payments for form NC-5Q at this time. If the return has an underpayment, use form NC-5PX to mail in your payment unless you are required to pay by Electronic Funds Transfer (EFT).
